**Terms and conditions for Sony Life Financial Advisers Pte. Ltd.  
Spring Campaign Sure-Win Lucky Spin 2023  
(15<sup>th</sup> Jan 2023 to 31<sup>st</sup> Mar 2023)**

1. The terms and conditions set below apply to the Sony Life Financial Advisers Pte. Ltd. ("SLFA") Spring Campaign Sure-Win Lucky Spin ("the Lucky Spin") which runs from 15<sup>th</sup> Jan 2023 to 31<sup>st</sup> Mar 2023 (both dates inclusive).
2. Subject to the terms and conditions of the Lucky Spin, customers who purchase any of the Life/Accident & Hospitalisation insurance products shall be entitled to participate in the Lucky Spin. A customer is defined herein as an "applicant of the insurance policy".
3. The customer is entitled to one lucky spin for every policy purchased, regardless of the amount of the premium paid for the policy.
4. The Lucky Spin is open only to customers who are residents and permanent residents of Singapore and above the age of 21.
5. The Lucky Spin prizes consist of e-vouchers of \$10 or \$20 value from NTUC FairPrice, Starbucks and Capitaland Malls.
6. The prizes are subject to availability. SLFA reserves the right to stop the Lucky Spin when all prizes have been given out.
7. Customers must provide all the information (including the amount of the prize money) for redemption purpose in the prescript redemption form. The onus is on the customer to ensure all the information provided is accurate.
8. The e-vouchers will be sent to the customers via email within 14 days after SLFA received the redemption form.
9. SLFA is not responsible for non-receipt of vouchers if a customer provided an incorrect email address or neglected to inform SLFA of change of email address provided in the redemption form.
10. The prizes cannot be exchanged for cash, is non-transferable and non-assignable.
11. SLFA reserves the right to all legal recourse and/or compensation for the recovery of the prize from the customer.
12. Staff purchases are excluded from participating in the Lucky Spin.
13. SLFA reserves the right to vary the terms and conditions or withdraw the Lucky Spin at any time without prior notice.
14. The decision of SLFA on all matters relating to the Lucky Spin shall be final and binding on all customers.
